Assistant or Associate Professor | ICORD (International Collaboration on Repair Discoveries) | Department of Pathology and Laboratory Medicine

The International Collaboration on Repair Discoveries (ICORD), a research centre in the Faculty of Medicine at the University of British Columbia (UBC), is partnering with the UBC Department of Pathology and Laboratory Medicine to seek an outstanding basic spinal cord injury (SCI) researcher with a focus on the recovery and regeneration of the injured spinal cord.

ICORD ([www.icord.org](http://www.icord.org)) is an interdisciplinary research group with 45 principal investigators collaborating on its vision to make SCI preventable, livable, and curable. ICORD has its home in a 10,000 m<sup>2</sup> state-of-the-art research facility on the Vancouver General Hospital campus, shared with our partners the Rick Hansen Institute and Vancouver Coastal Health's Brenda and David McLean Integrated Spine Clinic.

The successful applicant will be recommended for a tenure-track appointment at the rank of Assistant or Associate Professor within the Department of Pathology and Laboratory Medicine. We are seeking a scientist who will be a collaboratively spirited colleague with excellent interpersonal skills and who will execute a vigorous research program related to neuroprotection, neural regeneration, and/or neural repair, while contributing to our common goal of translation into humans with SCI. The successful applicant is required to have exceptional communication skills, ability to foster a strong record of research productivity commensurate with their experience, demonstrated potential in establishing a successful research program; and a PhD degree, MD/PhD, or equivalent with postdoctoral research experience in basic SCI research. The successful applicant will also have demonstrated or a demonstrated potential for excellence in undergraduate, graduate, and postgraduate teaching as well as supervision of students and trainees at all levels, and will be expected to actively participate in departmental and faculty activities. Academic rank and salary will be commensurate with qualifications and experience.
